

# PRIVACY POLICY

Highway Wanderers, a Chapter of Campervan & Motorhome Club of Australia Limited (ACN 095 568 157), gives priority to protecting the privacy of your personal information. We do this by handling personal information in a responsible manner and in accordance with the Privacy Act 1988 (Cth). In this Privacy Policy, 'we', 'our', 'us', 'the Chapter' or 'HW' means Highway Wanderers.

## How We Collect Your Personal Information

We collect your personal information from you, the member, for membership purposes and for the purpose of providing you with a range of services. The information is provided by you to ensure accuracy of data. The member is required to keep us up to date with changes to this information, including address, phone contacts and current email addresses and partner details where appropriate. It is your responsibility to ensure this information is up to date. If you do not have access to your member profile, we ask you to contact the Committee ([committee@highwaywanderers.net](mailto:committee@highwaywanderers.net)) advising of the required changes.

## Why We Collect Your Personal Information

We collect your personal information to enable us to record you as a member of Highway Wanderers so that we can keep you informed of Chapter events and news and to provide our services. As a member of the Highway Wanderers you have agreed for some of your details to be made available to other members.

## Who We Disclose Your Personal Information To

We will only disclose your personal information to other Highway Wanderer members as described in the section above headed 'Why We Collect Your Personal Information'. We may also disclose your personal information to CMCA for the purpose of ensuring that their membership database accurately reflects those of their membership who belong to the HW Chapter. Disclosure may also be made to government, law enforcement agencies, those assisting or involved in dispute resolution, various statutory or regulatory bodies, or as required by law. We impose strict conditions on organisations with which we may share your personal information. We will not sell or rent your personal information to another organisation.

HW will never disclose your personal information to anyone outside Australia.

### **Review**

HW regularly reviews the security of our systems used for sending and storing personal information. Any personal information disclosed may only be used for the purposes of collection described above. Both our Privacy Policy and the established procedures commit us to keeping your personal information safe and secure. Appropriate safety measures and technology are used to ensure your personal information is protected.

### **Access to Your Personal Information**
